**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
GAR M2 CS RACING LLC**

WHEREAS, the name of the company is GAR M2 CS RACING LLC, a Florida limited liability company ("Company"); and

WHEREAS, the Company was formed pursuant to the laws of the State of Florida on October 31, 2023 and assigned document number L23000493167; and

WHEREAS, the Organizer of the Company has recommended the amendment to the Articles of Organization set forth below; and

WHEREAS, the undersigned Company, by and through its Organizer and pursuant to the provisions of the Florida Statutes, agreed to amend the aforesaid Articles of Organization in the manner hereinafter set forth;

NOW, THEREFORE, the undersigned hereby amends the Articles as follows:

1. Article IV of the Articles of Organization is hereby modified and is restated as follows:

**"ARTICLE IV
MANAGEMENT**

The Company shall be managed by the Manager of the Company as provided in the Company's Operating Agreement. The initial Manager of the Company is GAR Racing Holdings LLC, with an address of 1234 Red Haven Lane, Oviedo, Florida 32765, which shall serve until replaced according to the provisions of the Company's Operating Agreement."

2. The date of the foregoing amendment's adoption was as of October 31, 2023.

3. Except as modified herein, the Articles of Organization of said Company shall be and remain in full force and effect.
