**ARTICLE I
COMPANY NAME**

PURPOSE**



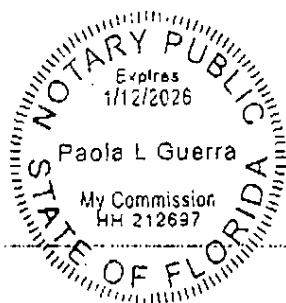
