To Whom It May Concern:

I am attaching this letter regarding the Articles of Conversion and Articles of Organization being filed to the state of Florida. I would like to explain the reasoning I am filing these articles and would like verification that I am submitting the correct forms.

My intention is to convert/domesticate the Limited Liability Company (collectively, "LLC") to Florida and be recognized under Chapter 605 of Florida Statutes. I understand some state use "Conversion" and "Domestication" interchangeably and want to make sure the LLC is being recorded with state properly.

However, the Articles of Domestication on the Division of Corporations website states the filing is for Articles of Domestication of a Non-US Entity. Since my LLC is a US entity, I did not believe this was the correct form to submit.

The enclosed Articles of Conversion states this form is to convert an "Other Business Entity" into a Florida LLC. Since the entity is currently classified as an LLC, I do not know if Florida recognizes this entity as an "Other Business Entity" since it was created outside of the state of Florida and the Articles of Conversion transfers the entity into a Florida LLC.

The LLC was formed and created in the State of Ohio. I would like the LLC to be converted/domesticated into a Florida LLC and Florida be recognized as the entity's home state/headquarters.

If the enclosed forms are incorrect and Articles of Domestication need to be submitted, please contact me as soon as possible and I will correct the filing. Thank you for your time and efforts.
