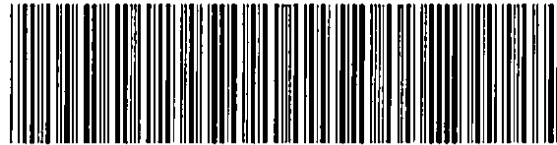

### **ARTICLE V - MANAGEMENT**


