**ARTICLES OF ORGANIZATION  
OF

1. Name. The name of this limited liability company is MAZZ LLC (the "Company"), and it shall be formed as a limited liability company under Chapter 605 of the laws of the State of Florida.

2. Place of Principal Office. The mailing and street address of the Company's principal office is 244 5<sup>th</sup> Ave., Suite 2025, New York, New York, 10001.
