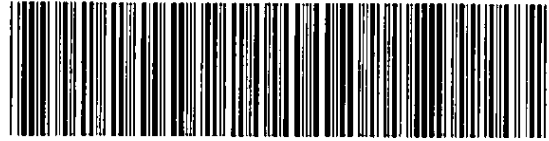

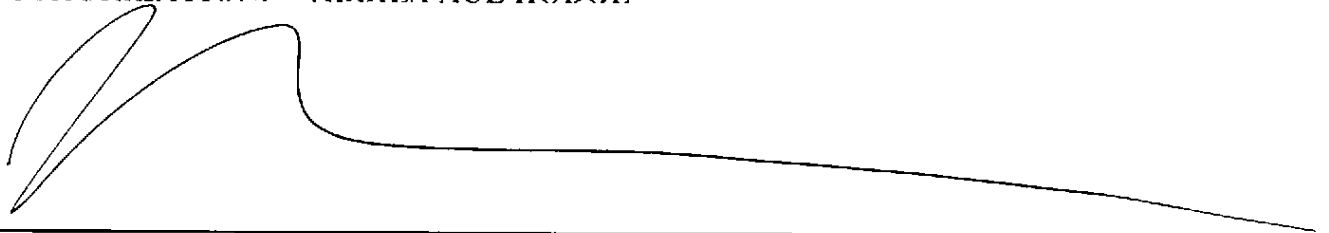

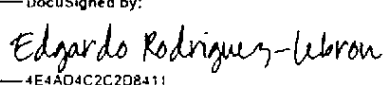
ARTICLE V. MANAGEMENT
