

**ARTICLES OF ORGANIZATION
OF
PEARLE VISION PSL, LLC**

The undersigned, member or an authorized representative of a member, adopts these Articles of Organization and forms a limited liability company (the "**Company**") under the Florida Revised Limited Liability Company Act (the "**Act**"), as follows:

**ARTICLE 1
NAME**

These Articles of Organization of the Company shall be effective as of the filing date.

The Company shall not engage in any business activity other than that which is directly related to the operation of a Pearl Vision retail optical ("Pearl Vision") or such other business operation as shall be approved in writing by Pearl Vision.


ARTICLE 7


