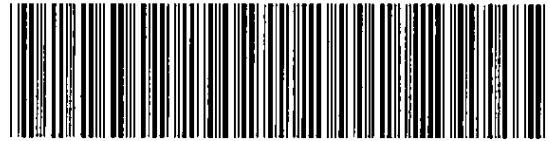

The name of the Limited Liability Company is **TOPNK Medical Supplies, LLC**.

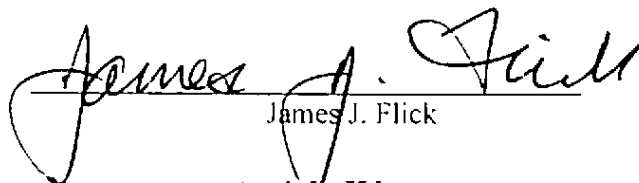
Article II

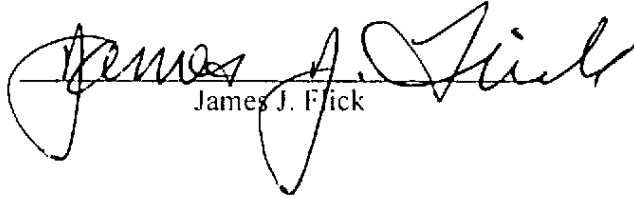
