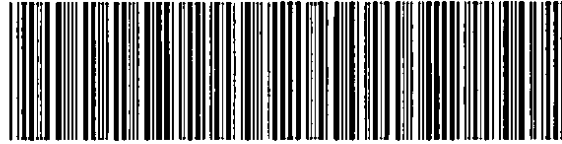




**ARTICLE IV.


