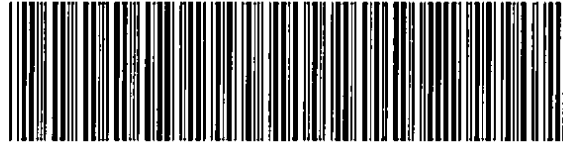

**ARTICLES OF ORGANIZATION  
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, pursuant to Chapter 605 of the Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization (the "Articles").

**ARTICLE I. NAME**

The name of the limited liability company is Summit Investors II, LLC (the "Company").

The mailing address and street address of the principal office of the Company shall be 2930 W County Hwy 30A, Suite 206, Santa Rosa Beach, Florida 32459.

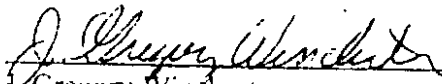
**ARTICLE III. REGISTERED AGENT AND OFFICE**
