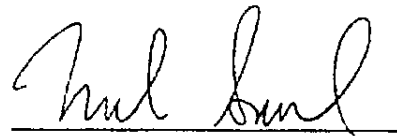
**ARTICLE VII**

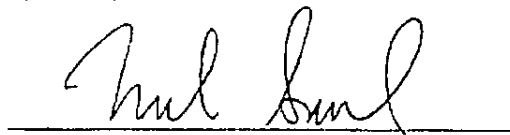
