# ARTICLES OF ORGANIZATION OF CRAFT CONCIERGE OF FLORIDA, LLC

The undersigned hereby executes these Articles of Organization for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

## ARTICLE I

# **Name**

The name of this limited liability company (the "Company") shall be Craft Concierge of Florida, LLC.

## ARTICLE II

# Principal Office and Mailing Address

#### ARTICLE III

## Duration; Effective Date

The Company shall have perpetual existence.

# Registered Office and Registered Agent
