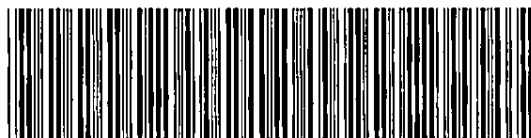

ARTICLES OF ORGANIZATION

**ARTICLE I**

**Name**

The name of the limited liability company ("Company") is STREET ART BREWING, LLC.

**ARTICLE II**

**Address**

The mailing and street address of the Company's principal office is: 1001 Douglas Avenue, Duncedin, Florida 34698.

**ARTICLE III**

**Purpose**

This limited liability company is organized to engage in the following purposes: operating a brewing and tap room and related business and any and all lawful business for which companies may be organized under the laws of the State of Florida.

**ARTICLE IV**

**Duration**

The period of duration for the Company is perpetual, beginning on the date that these Articles of Organization are filed by the Florida Department of State.

**ARTICLE V**

**Registered Agent and Office**

The name of the Company's initial registered agent in Florida is Patricia L. Norton. The address of the Company's registered office in Florida is 2010 Water Wheel Court, Duncedin, FL 34698.

## ARTICLE VI

### **Initial Members**

The name and address of the initial members of the company and his/her respective interests in the company are:

Any member shall have authority to bind the company.

## ARTICLE VII

### **Admission of Additional or New Members**

Members of the Company have the right to admit new members. Additional or new members may be admitted only on the unanimous written consent of the existing member or members, and the existing member or members shall determine the amount and nature of contributions to be made by the additional or new members at the time those new members are admitted.

## ARTICLE VIII

### **Management**

The Company is to be managed by managers. The initial managers will serve until the first annual meeting of the members or until the managers' successors are elected and qualified. The initial manager is identified as John M. Norton, II, whose address is 9235 Covey Hollow Court, Charlotte, North Carolina 28210.

## ARTICLE IX

### **Continuance of Business**

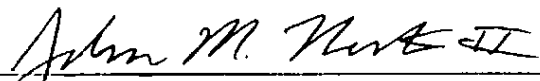
The remaining member or members of the Company have the right to continue the business on the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member or the occurrence of any other event which terminates the continued membership of a member in the Company. The business may be continued only on the unanimous written consent of the remaining member or members.

The power to adopt, alter, amend or repeal the regulations of the Company is vested entirely in the manager listed in Article VIII.

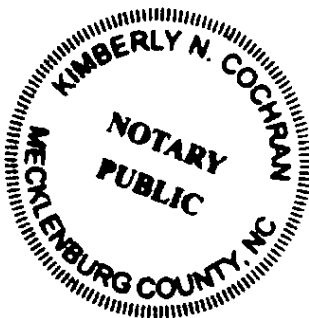

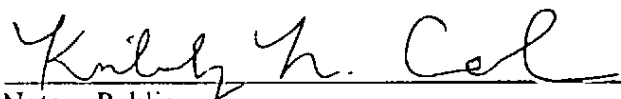
