#### AMENDED ARTICLES OF ORGANIZATION OF STREET ART BREWING, LLC

#### ARTICLE I

#### Name

The name of the limited liability company ("Company") is STREET ART BREWING, LLC.

#### ARTICLE II

#### Address

The mailing and street address of the Company's principal office is: 1001 Douglas Avenue, Dunedin, Florida 34698.

#### Purpose
