**ARTICLES OF ORGANIZATION
OF
WALSH-PATEL HOLDINGS LLC**

The undersigned, acting as the organizer of WALSH-PATEL HOLDINGS LLC, desiring to form a limited liability company under and pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is WALSH-PATEL HOLDINGS LLC (the "Company").

ARTICLE II. ADDRESS

The mailing address of the Company is P.O. Box 205, Gotha, Florida 34734. The principal office address of the Company is initially 9310 Westover Club Circle, Windermere, Florida 34786.

ARTICLE III. EFFECTIVE DATE AND DURATION

The period of duration for the Company shall be perpetual, unless dissolved in accordance with the terms of the Operating Agreement of the Company.
