ARTICLES OF ORGANIZATION
OF
BVL OYSTER BAR, LLC,
a Florida limited liability company

The undersigned organizer and authorized representative of a limited liability company to be formed under the Florida Limited Liability Company Act, as amended (the "*Act*"), does hereby certify that the persons so identified herein have associated themselves together for the purpose of forming a limited liability company (the "*Company*") under the laws of the State of Florida, pursuant to the Act, and hereby sets forth the following Articles of Organization (these "*Articles*");

ARTICLE I
NAME

The name of the Company shall be: **BVL OYSTER BAR, LLC, a Florida limited liability company.**

ARTICLE II
ADDRESS AND PLACE OF BUSINESS

The principal place of business of this Company shall be 14445 Ponce De León, Brooksville, Florida 34601, and, the mailing address of this Company shall be Post Office Box 385, Brooksville, Florida 34605, and such other place or places as may be designated by the Manager(s) from time to time.

ARTICLE IV
GENERAL POWERS

The Company is formed for the purpose of conducting and undertaking, and shall have the power to conduct and undertake, any and all activities and actions authorized under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes.

ARTICLE V
MANAGEMENT

All powers of the Company shall be exercised by or under the authority of the manager and, except as otherwise provided in the operating agreement of the Company, if any ("Operating Agreement"), the business and affairs of the Company shall be managed by or under the direction of the manager. ARTICLE VI
OPERATING AGREEMENT

The members of the Company may adopt an operating agreement pertaining to the regulation, management, and other affairs of the Company (previously defined as the Operating Agreement), provided that such Operating Agreement shall not be inconsistent with these Articles of Organization or with the laws of the State of Florida. The Operating Agreement may be repealed or altered only in the manner now or hereafter prescribed therein, consistent with the laws of the State of Florida.

ARTICLE VII
REGISTERED OFFICE AND REGISTERED AGENT

The street address of the Company's initial registered office in Florida is **401 E. Jackson Street, Suite 3100, Tampa, Florida 33602**, and the name of its initial registered agent is **Sheada Madani, Esquire**. The Company may change its registered office or its registered agent or both by filing with the Department of State of the State of Florida a statement complying with Section 608.416, Florida Statutes.
