# ARTICLES OF ORGANIZATION OF OPTIC 2023 PASSIVE INVESTMENTS LLC

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

#### ARTICLE I Name

The name of the limited liability company shall be Optic 2023 Passive Investments LLC.

#### ARTICLE II Address and Place of Business
