**ARTICLES OF ORGANIZATION FOR  
PROFESSIONAL LIMITED LIABILITY COMPANY**

The undersigned does hereby present these Articles of Organization for the formation of a professional limited liability company under the provisions of Chapter 621, Florida Statutes.

**ARTICLE I - Name**

The name of the Professional Limited Liability Company is:

**ARTICLE II - Address**

**ARTICLE III - Duration**

**ARTICLE IV – Purpose and Powers**

A member's interest in the Professional Limited Liability Company may not be sold or otherwise transferred except to a transferee authorized to be a member pursuant to this Article V and otherwise in accordance with the Operating Agreement of the Professional Limited Liability Company, as amended and/or restated.




