The undersigned, Gary Lee, a natural person competent to contract and an authorized representative of Lee Coyote, LLC, hereby presents these Articles of Organization as the Articles of Organization of Lee Coyote, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

**ARTICLE I - NAME**

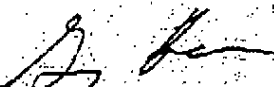
