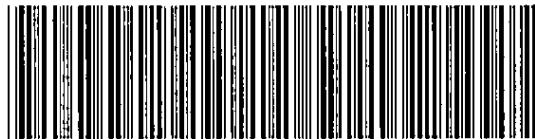




ARTICLE IX - MANAGEMENT

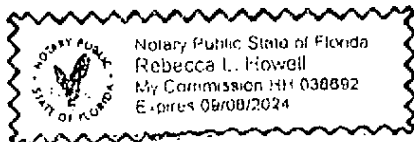

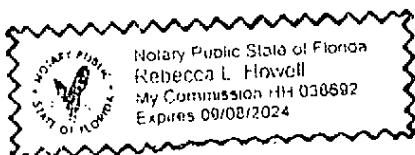
