ARTICLES OF ORGANIZATION
OF
SINGER ISLAND ERRAND & DELIVERY SERVICE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE I – Name

The name of the Limited Liability Company is SINGER ISLAND ERRAND & DELIVERY SERVICE, LLC (the “Company”).

ARTICLE VI – Additional Capital Contributions

Each member shall make additional capital contributions to the company only upon the unanimous consent of the Managing Members.

ARTICLE VII – Admission of New Members

No additional members shall be admitted to the Company except with the unanimous written consent of the Managing Members of the Company and upon such terms and conditions as shall be determined by the Managing Members.
