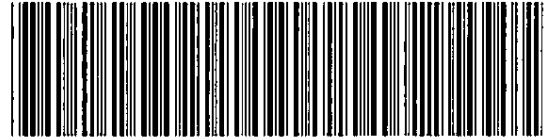



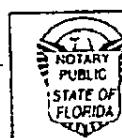

PURSUANT TO THE POWERS RESERVED IN THE GRANTOR/SETTLOR, JOAN F. RAVENNA, TO AMEND HER TRUST KNOWN AS THE JOAN F. RAVENNA LIVING TRUST, DATED FEBRUARY 23, 2010, JOAN F.
