# AMENDED AND RESTATED ARTICLES OF ORGANIZATION FOR ARACELIS ENTERPRISE LLC

Pursuant to Section 605.0202, of the Florida Revised Limited Liability Company Act, Aracelis Enterprise LLC (the "Company"), hereby amends and restates its Articles of Organization as originally filed with the Florida Department of State on December 4, 2023, Document Number L23000535707, said Amended and Restated Articles to become effective upon filing with the Florida Secretary of State. The Company hereby restates its Articles of Organization to read as follow:

# ARTICLE I Name

The name of the Company is Aracelis Enterprise LLC, a Florida limited liability company.

# ARTICLE II Commencement Date and Duration

The Company's existence commenced on December 1, 2023, and shall continue perpetually unless dissolved in accordance with Section 605.0701 of the Act.

# ARTICLE III Purpose

The Company is created to conduct any lawful business under the laws of the State of Florida.

# ARTICLE IV Principal Office

The mailing address and the street address of the principal office of the Company is 140 Riviera Dunes Way, Apt. 704, Palmetto, Fl. 34221.

# ARTICLE VI Management of Business

The Company shall be managed by one or more Managers who are elected or appointed by the Members as provided in the Operating Agreement for the Company. The initial manager of the Company is Stephen W. Hall.

## ARTICLE VII

# Admission of Additional Members

Additional Members may be admitted as provided in the Operating Agreement, upon terms and conditions established by the Members from time to time in their sole discretion.

## ARTICLE VIII

### Powers

The Company shall have all of the powers and authority set forth in Section 605.0109 of the Florida Statutes.

## ARTICLE IX

#### Property

- (a) Ownership. All funds paid to the Company as contributions to capital by the Members, and all property acquired by the Company by purchase or otherwise, shall be the property of the Company.
- (b) <u>Title.</u> The title to all property of the Company shall be held in the name of the Company.

## ARTICLE X

## Amendments

These Articles may be amended or restated at any time by the vote or consent of a majority in interest of the Members, as defined in the Operating Agreement. Such amendment or restatement shall be filed with the Florida Department of State in accordance with the provisions of Section 605.0206 of the Florida Statutes.

## ARTICLE XI

# Operating Agreement

An Operating Agreement shall be prepared and adopted to govern the internal affairs of the Company containing such provisions as may be necessary, reasonable, or desirable, except that no provision of such Operating Agreement may conflict with the provisions of these Articles. The power to adopt, alter, amend, or repeal the Operating Agreement shall be set forth therein.
