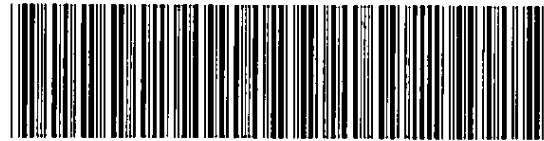

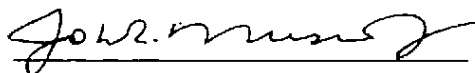

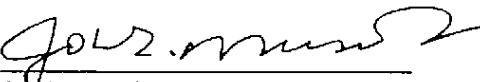
ARTICLE VII
