# ARTICLES OF ORGANIZATION of INTRACOASTAL FISHERIES MANAGEMENT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605 (the "Act"), hereby makes, acknowledges and files the following Articles of Organization.

### ARTICLE I

#### NAME

The name of the limited liability company shall be Intracoastal Fisheries Management, LLC (the "Company"). The mailing and street address of the principal office of the Company shall be 233 Rivershore Lane, Saint Augustine, Florida 32084.

#### ARTICLE II

# PURPOSES AND POWERS

The Company shall be terminated and dissolved pursuant to the terms of the Company's operating agreement, which may be amended from time to time, or in the absence of an operating agreement, by the Act.

# ARTICLE VI

### MANAGER

The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. The manager shall be elected in the manner set forth in the Operating Agreement of the Company.
