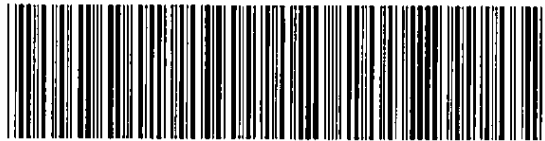

**ARTICLES OF ORGANIZATION

The undersigned, being a duly authorized representative of the Member(s), desiring to form a limited liability company under and pursuant to the Florida Limited Liability Company Act, Chapter 605, Florida Statutes (the "Act"), does hereby adopt the following Articles of Organization:

ARTICLE I. NAME

The name of the limited liability company is 6255 Olivedale, LLC (the "Company").

ARTICLE II. ADDRESS

The principal address of the Company is 6255 Olivedale Drive, Riverview, FL 33578 and the mailing address of the Company is 501 Knights Run Circle, Tampa, FL 33602.
