- SECOND:** The Articles of Organization were filed on December 21, 2023, effective January 2, 2024 and assigned document number L23000558224.
- THIRD:** The date of the adoption of these Articles of Dissolution is 21 March 2024.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709. The remaining property and assets have been distributed among its members in accordance with their respective rights and interests.
