For the reasons described below, the undersigned will carry out the winding up of the Company (solely for purposes of complying with the Florida Statutes). All notices should be sent to the address listed below.

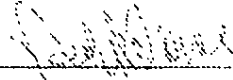

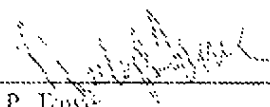
