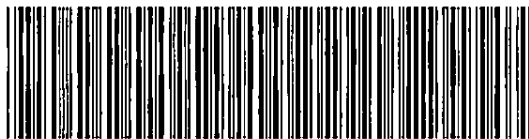

The name of the Limited Liability Company shall be **TRIM THIS, LLC**.




