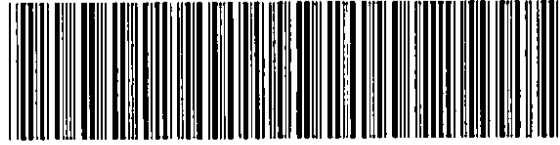

ARTICLES OF ORGANIZATION OF A
FLORIDA LIMITED LIABILITY COMPANY

ARTICLE I - NAME


