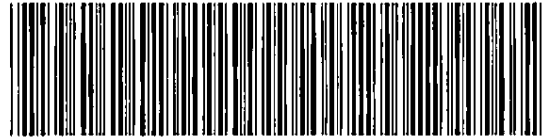

The name of the Registered Agent is KRIS M. CREEDEN. The Registered Office is located at 529 Blue Cypress Drive, Groveland, Florida 34736.


**ARTICLE IV.
