**ARTICLES OF ORGANIZATION**  
*of*  
**2005 BEACH AVENUE, LLC**

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605 (the "*Act*"), hereby makes, acknowledges and files the following Articles of Organization.

**ARTICLE I**

**NAME**

The name of the limited liability company shall be 2005 Beach Avenue, LLC (the "*Company*"). The mailing and street address of the principal office of the Company shall be 2005 Beach Avenue, Jacksonville, Florida 32210.

**ARTICLE II**

**PURPOSES AND POWERS**

The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company.
