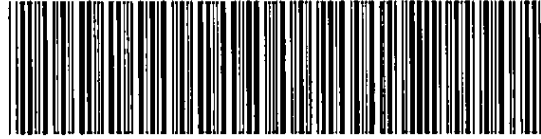

1. Name. The name of the limited liability company formed hereby is:

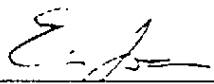
