Lastowski, natural person competent to contract and an authorized representative of AMFLO SALEM, LLC, hereby present these Articles of Organization as the Articles of Organization of AMFLO SALEM, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is AMFLO SALEM, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS


ARTICLE VI - MANAGEMENT


