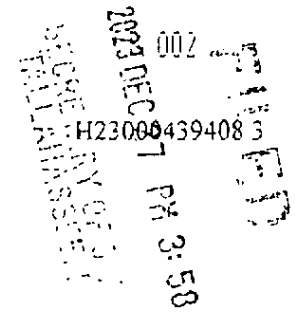

**ARTICLES OF ORGANIZATION  
OF

Lastowski, natural person competent to contract and an authorized representative of AMFLO OLIVE 2, LLC, hereby present these Articles of Organization as the Articles of Organization of AMFLO OLIVE 2, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is AMFLO OLIVE 2, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**

**ARTICLE III - PURPOSE AND POWERS**


