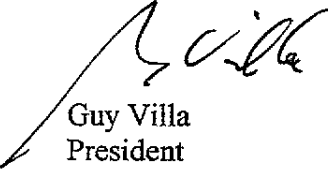

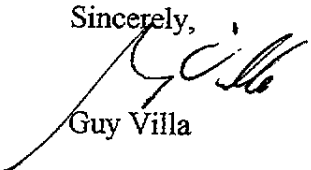

Pursuant to the provisions of section 607.1006, Florida Statutes, this Florida profit corporation adopts the following articles of amendment to its articles of incorporation:

FIRST: Amendments adopted:

ARTICLE I – NAME

is amended to read as follows:

The name of the corporation shall be TITAN POOLS COMPANY.

ARTICLE X – RESIDENT AGENT

is amended to read as follows:

The resident agent of this corporation shall be Guy Villa, 7 San Marco Court, Palm Coast, Florida 32137, which resident agent shall accept service of process in this state.

SECOND: These amendments to the Articles of Incorporation do not exchange, reclassify or cancel any issued shares of stock of the corporation.

THIRD: These amendments shall be adopted September 15, 2000 and shall be effective September 26, 2000.

FOURTH: These amendments were unanimously approved by the shareholders and the directors of the corporation.
