ARTICLES OF AMENDMENT

Article I of the Articles of Incorporation of Saalfield, Coulson & Jay, P.A., formerly known as Saalfield, Catlin & Coulson, P.A., formerly known as Saalfield, Catlin, Coulson & Etheridge, P.A., formerly known as Saalfield, Catlin, Coulson, Stoudemire & Etheridge, formerly known as Harold H. Catlin, P.A., originally filed in Tallahassee, Florida on the 17th day of October, 1989, and amended by Amendments filed in Tallahassee, Florida on April 11, 1997, on March 11, 1994, on November 22, 1991 and November 29, 1989, respectively, is hereby amended to read-48 follows:

ARTICLE I

Corporate Name
