SHAREHOLDER APPROVAL**


The number of votes cast by the shareholders for dissolution was sufficient for approval.

The Effective Date of these Articles of Dissolution is May 31, 1998.



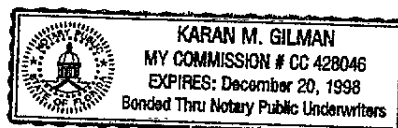
