## ARTICLES OF ORGANIZATION OF Neuron PLLC

Pursuant to Sections 605.0201 of the Florida Revised Limited Liability Company Act, Florida Statutes, and Section 621.051 of the Florida Professional Service Corporation and Limited Liability Company Act, Florida Statutes, each as amended from time to time (collectively, the "Act"), the following Articles of Organization are hereby adopted:




