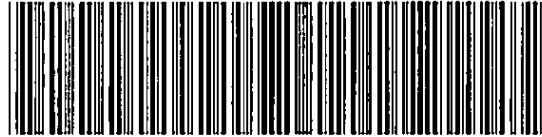

ARTICLE I: NAME

The name of the limited liability company is Well&You ManageCo, LLC (the "LLC").


ARTICLE II: ADDRESS
