Subject: Statement of Fact – Unauthorized Alteration in Records of JJ Petroleum USA LLC

Statement of Fact

I, Jonatan Machado Ponce, owner of JJ Petroleum USA LLC (Document Number: L24000009491), located at 6320 Narcoossee Rd, Orlando, FL 32822, hereby declare that an unauthorized alteration was made to the company's records in the Division of Corporations system.

On January 6, 2025, I became aware of an **unauthorized update** to the company's records, which added an individual as Managing Member of JJ Petroleum USA LLC. This change was made without my knowledge or consent and directly contradicts the documented structure of ownership and management of the company.

I am the **sole owner** of **JJ Petroleum USA LLC**, and I have been operating the business independently **since February 2024**. This structure is supported by **documents filed** with the Florida Secretary of State and the IRS, as well as operational records and filings that reflect my exclusive management and ownership.

Furthermore, in **February 2024**, official documents **were signed in person** at **Prime Income Tax and Accounting LLC** to formalize the ownership and management structure of JJ Petroleum USA LLC. These actions were filed with the appropriate authorities, ensuring compliance with Florida corporate laws.

To ensure the integrity of the company's records, I submitted a **Statement of Authority** to the Division of Corporations on December 3, 2024, declaring that no changes could be made to the company's records without my explicit consent and signature. However, I have contacted the Department of State, and they have confirmed that the document is currently being processed and that the certificate will be issued shortly.

This unauthorized alteration undermines the principles of corporate governance and directly violates the integrity of the records held by the Division of Corporations.


