ARTICLES OF ORGANIZATION OF GI HEALTH SPECIALISTS OF FLORIDA, LLC

The undersigned hereby executes these Articles of Organization for the purpose of forming a limited liability company in accordance with the laws of the State of Florida.

ARTICLE 1

Name

The name of this limited liability company (the "Company") shall be GI Health Specialists of Florida, LLC.

ARTICLE II

Principal Office and Mailing Address

The address of the principal office and the mailing address of the Company shall be 12191 West Linebaugh Avenue, Suite 770, Westchase, FL 33626.

ARTICLE III

Duration: Effective Date

The Company shall have perpetual existence.

ARTICLE IV

Registered Office and Registered Agent

The initial registered office of the Company shall be located at be 9585 Cavendish Drive, Tampa, FL 33626, and the initial registered agent of the Company at such office shall be Badal Shah. The Company shall have the right to change such registered office and such registered agent from time to time, as provided by law.

ARTICLE V

Operating Agreement

The power to adopt the operating agreement of the Company, to alter, amend or repeal the operating agreement of the Company, or to adopt a new operating agreement, shall be vested in the members of the Company. The operating agreement of the Company shall be for the governance of the Company.
