**ARTICLES OF ORGANIZATION
OF

The undersigned, acting as an authorized representative of the initial members of the above captioned Limited Liability Company, under the provisions of the Florida Revised Limited Liability Company Act, Chapter 605, *Florida Statutes*, adopts the following Articles of Organization:

**ARTICLE I
NAME & ADDRESS**

The name of this limited liability company shall be **DESIGN GONZALEZ, LLC** (the "Company") and its principal office is 1801 S. Flagler Dr. Unit 1703, West Palm Beach, Florida 33401, and its mailing address is P.O. Box 2797, Palm Beach, Florida 33480.

**ARTICLE II

**ARTICLE III
INITIAL REGISTERED OFFICE AND AGENT**


