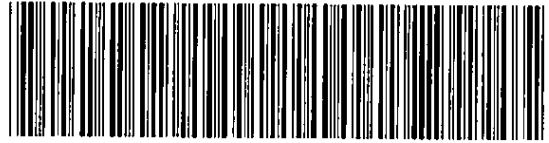

ARTICLES OF ORGANIZATION

OF

FAMILY CHURCH - 13, LLC

The undersigned, to form a single-member Florida limited liability company under the Florida Revised Limited Liability Company Act, F.S. Chapter 605, et seq., (the "Act"), make, acknowledge, and file the following Articles of Organization.

ARTICLE I - NAME

The name of the limited liability company shall be Family Church - 13, LLC (the "Company"); provided, however, that the member may, to the extent permitted by the Act, change the name of the Company at any time or from time to time and cause the company to do business at the same time under one or more fictitious names if the member deems it is in the best interest of the Company.

ARTICLE II - ADDRESS

The mailing address and street address of the Company's principal office is **1101 S. Flagler Drive, West Palm Beach, Florida 33401.**

ARTICLE III - DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State, Division of Corporations. The Company's existence shall be perpetual unless the Company is dissolved earlier as provided in these Articles of Organization, the Operating Agreement, or the Act.

ARTICLE IV - REGISTERED OFFICE AND AGENT

The name and street address of the Company's Registered Agent in the state of Florida is **Scott Crawford**, located at **1101 S. Flagler Drive, West Palm Beach, Florida 33401.**

ARTICLE V - MANAGEMENT

The Company shall be managed by the single member or its elected managers in accordance with the Operating Agreement adopted by the single member for the management of the Company's business and affairs. The Operating Agreement may contain any provisions for regulating and managing the Company's affairs that are not inconsistent with the law or these Articles of Organization. 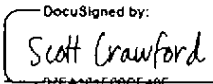
