**ARTICLES OF ORGANIZATION
OF

The undersigned, Kyle Groth, a natural person competent to contract and an authorized representative of Bernard Barrel Group I LLC, hereby presents these Articles of Organization as the Articles of Organization of Bernard Barrel Group I LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Bernard Barrel Group I LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

The date for commencement of the Company's existence shall be January 15, 2024. The Company shall have a perpetual existence unless the Company is terminated as provided in its Operating Agreement.


ARTICLE V - REGISTERED OFFICE AND AGENT


