# ARTICLES OF ORGANIZATION OF FABIAN PROPERTY, LLC

This statement of authority is made pursuant to section 605.0302(1), Florida Statutes.

- (a) Manager's Unanimous Authority. No person dealing with the Manager(s) need inquire into the validity or propriety of any document or instrument executed in the name of the Company by the Manager(s) unanimously, or as to the authority of the Manager(s) in executing the same.
- (b) <u>No Authority to Other Persons</u>. No other persons shall have any authority, without the prior written consent of the Manager(s) or Member(s) of the Company, to enter into any transaction on behalf of, or otherwise act for or bind, the Company.

#### ARTICLE VIII. INDEMNIFICATION

The Company shall indemnify any member, manager, officer, director, employee, or agent, and any former member, manager, officer, director, employee, or agent, to the full extent perinitted by law.
