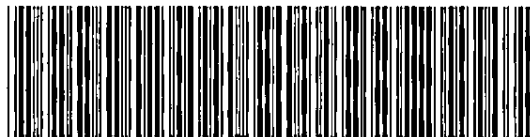

MANAGEMENT**

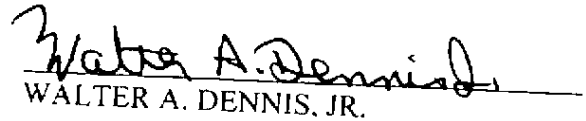

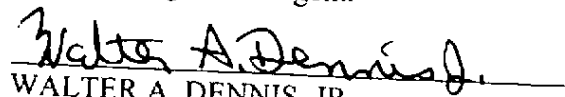
