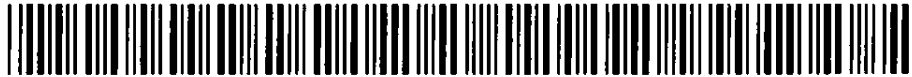

Name

The undersigned, as the sole member of **COASTAL COPYWRITER, LLC**, hereby executes and adopts the following Amended and Restated Articles of Organization of the limited liability company ("Company") **COASTAL COPYWRITER, LLC**.

Article II

Admission of New Members

Members of the Company have the right to admit new members.
