- SECOND:** The Articles of Organization were filed on January 23, 2024 and assigned document number L24000036392.
- THIRD:** The date of the adoption of these Articles of Dissolution is 27 March 2024.
- FOURTH:** The dissolution of the Limited Liability Company was a unanimous agreement of all members. It is agreed that all debts, obligations and liabilities of the limited liability company have been paid or discharged, or that adequate provision has been made, pursuant to section 605.0709.
