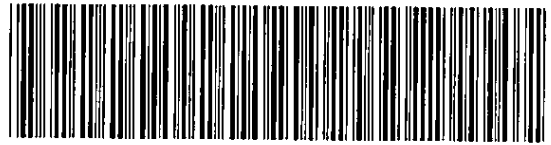

**ARTICLES OF ORGANIZATION**  
**OF**

The undersigned organizer, who is the Organizer and Manager of SLU Non Potable Water, LLC, a Florida limited liability company (the "Company") under the Florida Revised Limited Liability Company Act (the "Act"), hereby adopts the following Articles of Organization (the "Articles").

**ARTICLE 1 - NAME**

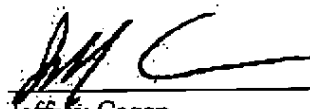
**ARTICLE 7 - AMENDMENT OF ARTICLES OF ORGANIZATION**
